## Appendix 1

## **Teacher / Coach Code of Conduct**

I agree to:

- Consider the wellbeing and safety of athletes/participants before the development of performance.
- Develop an appropriate working relationship with athletes/participants, based on mutual trust and respect and promote respect for the ability of opponents as well as for officials and fellow coaches/teachers.
- Always promote the positive aspects of the sport (e.g. fair play)
- Make sure all activities are appropriate to the age, ability and experience of those taking part.
- Encourage athletes to value the performance and not just results.
- Hold the appropriate, valid qualifications and insurance cover.
- Never consume alcohol immediately before or during training or events.
- Never condone rule violations, rough play or use of prohibited substances.
- Display consistently high standards of behaviour and appearance, dressing suitably and using appropriate language at all times whilst involved in coaching/teaching activities.
- Follow all guidelines laid down by the governing body and the club.
- Never exert undue influence over athletes/participants to obtain personal benefit or reward.
- Encourage and guide athletes/participants to accept responsibility for their own performance and behaviour.
- Follow the advice of a physician (doctor, physio, psychologist etc.) when a performer is injured.
- Make a personal commitment to keep yourself informed of sound coaching/teaching principles and the principles of growth, development and learning of children.
- Ensure that the equipment and facilities meet safety standards and are suitable for training.
- Abide by Scottish Swimming's Social Media Guidelines.

**Sanctions**: Breaches of the coach & teacher code of conduct will be dealt with in accordance with the relevant disciplinary procedures.
